Each dumpster rental includes up to 7 days of rental time. Unless a special request has been made, we will automatically schedule to pick up the dumpster for the same day as the delivery, the following week (i.e. Monday to Monday). It is your responsibility to contact us if you need the dumpster picked-up or swapped-out early. If you would like to extend the rental time beyond the PICKUP DATE listed on Page 1, please call us at least 2 days prior to that date. Each additional week is a flat rate of \$100.00. We cannot guarantee an extension, since there is a chance that we have already reserved the dumpster for another customer. Dumpster Rental Agreement

Conditions & Restrictions

- **LEVEL LOADS ONLY** – Over-loaded dumpsters (dumpsters loaded higher than the MAXIMUM LOAD LEVEL rim on the container) will not be hauled, and a return trip fee of \$250.00, \$100.00 flat weekly rate, will be applied to the cost of the service. We will return when the items above the rim have been removed. It is unlawful for us to haul loads higher than the side of the container.
- **DENSE MATERIAL** – Shingles, concrete, brick, plaster, etc. Small amounts of dense materials are permitted, but keep in mind that they are heavy, and your rental has a maximum weight capacity.
- **OVER-WEIGHT DUMPSTERS** – Dumpsters loaded heavier than suggested weight may not be picked up, and a return trip fee of \$250.00, \$100.00 weekly rate, will be applied to the cost of the service. We will return when the items causing the dumpster to be over-weight have been removed.
- **NO HAZARDOUS WASTE**
- **NO BIOMEDICAL, RADIOACTIVE WASTE**
- **NO LIQUID WASTE**- All liquids are prohibited from landfills. This includes wet paint and automobile fluids. Paint is accepted in dry form only. If wet paint is discovered, there will be a \$25.00 disposal rate per 1 Gallon or less.
- **NO TIRES** – Tires cannot be placed in the dumpster. If tires are discovered, there will be a \$25.00 disposal fee added for each tire.
- **NO HOT ASH or COAL** – No hot ash, coal, or any items that were once on fire and have not had ample time to fully extinguish.
- **MATTRESSES/BOXSPRING** – Mattresses and box springs are a separate charge of \$70.00 each.
- **UNACCEPTED MATERIALS**- Aerosol cans, liquids, animals, antifreeze, asbestos, chemical products, contaminated soil or any kind of soil, fluorescent tubes, freon, hazardous waste, herbicides & pesticides, hydraulic oil, motor oil, oil filters, other flammable liquids, paint (except completely dried latex paint), propane tanks, radioactive materials, railroad ties, rock/sand/dirt (in large quantities) and Hydro Post.



We will happily place the dumpster wherever you ask us to, as long as we deem it safe. You are responsible for all permits (if required) and any fine resulting from the lack of obtaining them.

We promise to treat your property the way we would want ours to be treated and do our best not to damage any property. That said, dumpster trucks and containers are heavy, and what you put in the dumpster will more than likely be heavy, so please understand that even though we take precautions not to damage property while delivering or picking up a dumpster, there is no way to guarantee that no damage will occur. McGrimmon Cartage assumes NO LIABILITY for property damage.

You are responsible for any damage done to the dumpster (besides normal wear). The following is not considered normal wear: burn marks, machinery or vehicle damage, paint/graffiti, holes & large dents etc.

PLEASE KEEP CHILDREN OUT OF, AND AWAY FROM THE DUMPSTER.

McGrimmon Cartage assumes NO LIABILITY for injuries sustained while in, on, around, or loading the dumpster.
